## STUDENT DRIVING AND PARKING AGREEMENT 2019-2020

*Be sure that both you and your parents read and understand this document before you sign it and before you purchase a parking pass. You cannot purchase a pass if you owe fines and fees from a previous year.*

- Secondary student drivers will need to obtain a parking permit through the office for the school year.
- When students submit their parking permit application they will be required to provide a copy of their driver's license, vehicle registration indicating make and model and insurance card. Students will be required to provide a copy of the registration for any additional vehicle(s) they may bring to school.
- Students who park on campus **must display the parking permit at all times** on the rearview mirror with numbers facing outward toward the front of the car. Repeated failure to display the hang tag may result in parking privileges being revoked.
- Students will park in the designated student parking lot located on the southeast corner of the building behind the secondary portables.
- Disabled vehicles may not be left on campus. Handicapped parking is state-mandated only. Parking for students disabled due to injury may be obtained on an individual basis in the main office.
- All drivers must abide by the Idaho Motor Vehicle Statutes regarding vehicle operation and seatbelt usage when on school grounds. Students must wear their seatbelts when entering, exiting, and while driving on campus. Speeding and reckless driving are prohibited. Students are prohibited from using cellular phones or any other hand-held devices while operating a motor vehicle. Vehicles must not travel in excess of 10 miles per hour while on campus.
- Supervision is provided for parking lots; however, the school is not responsible for damages to or theft from vehicles. Students are cautioned NOT to leave valuables in their vehicles. Parked vehicles should be left with windows closed and doors locked.
- Vehicles are subject to search and seizure if there is reasonable suspicion that drugs, alcohol, weapons, stolen property or other contraband are present. School Board Policy prohibits the possession or use of tobacco and vaping products on campus.

- Students are required to notify the Safe School Officer should their vehicle become disabled and is unable to be driven. Disabled vehicles will be required to be towed within 48 hours.

**Students who operate a motor vehicle on campus should understand their duties, responsibilities and the parking rules and regulations as listed above. Students who violate parking regulations are subject to revocation of parking privileges and or disciplinary action.**
