The latest CDC recommendation includes those under the age of 12 still wear a mask and those over 16 and not vaccinated wear a mask. The CDC will be issuing new guidance on July 19, 2021.

#### **CONTINUTING SCHOOL BUSINESS**

#### **School Report**

Melissa Andersen presented the IB results; this year had one of North Star's highest scores. The teachers were pleased by the results. Overall the students did really well, 81% passed for the Diploma. Andersen presented the Board with an overview of the Capstone program and the forward motion of the High School to continue to help the students be their best by the time they graduate from North Star. She informed the Board of the two programs IB and Capstone where

IB has a senior project, which includes an extended essay, and Capstone has all installed a senior project that starts during the junior year and concludes with a project that works with DECA. The Secondary Administration is starting a program this year in 8<sup>th</sup> grade using the book-Launch. The author is coming to North Star to help train. They are hoping to move this program into the 6<sup>th</sup> and 7<sup>th</sup> grades in the future.

Shay Davis and Laiena Leatherman were able to attend a principal conference in Chicago. They were excited to meet other principals and share their experience from the previous school year. The conference spoke about seeing that problems are starting to show with the stress of the past year. This summer many teachers at North Star are participating in an online conference through Solution Tree about personal well ness. Davis and Leatherman have been working on a school theme with the emphasis on bringing back the joy of education for teachers, staff and students.

The Board acknowledges the efforts and leadership skills of the Administration and Staff. They recognized Administration and Teachers who worked so diligently with all of the staff and families to make the school work during the past school year.

#### **Finance Update**

Finance presentation included in the agenda packet

Auditing is under way. Operating cash is tight, which is normal for this time of the year. Received the last of the State 2020-2021 payment. The proposed building changes are underway.

The Budget required adjusting since the Budget Hearing in June. There have been changes in Secondary Teachers page 7, which required adjustments to the budget. End result- the budget is very tight. On page 9, the Elementary Budget more was added to the Leadership Premiums. Secondary also added more to the Leadership premiums and added teachers with higher salary. SPED is steady, however, North Star does not receive much by way of State funding for this department. Eric is proposing that the administration be given responsibility for their budgets, which has not been the practice of North Star.

Eric is requesting the approval of the new budget.

Motion to approve the modify budget numbers by Director Forman. Second by Director Broadbent. Vote taken, all in favor. Motion passes.
