North Star Charter Coaches Services Agreement

This Independent Contractor (this "Agreement") is made effective as of November 1, 2021, by and between North Star Charter School, of 839 N. Linder Rd. Eagle Id. 83616, and Samantha Resendez of 2107 S. Leadville Ave., Boise Idaho 83706. In this Agreement, the party who is contracting to receive the services shall be referred to as "North Star", and the party who will be providing the services shall be known as "Coach".




