ATHLETIC DIRECTOR (.5 FTE)

SUMMARY:

The Athletic Director is responsible for overseeing all aspects of the athletic programs at North Star Charter School within their designated season. This includes program development, budgeting, hiring and supervising coaches, ensuring compliance with school policies and state athletic regulations, and fostering a positive and competitive environment for student-athletes.

ESSENTIAL DUTIES AND RESPONSIBILITIES:

Program Management:

- Develop, implement, and manage comprehensive athletic programs for middle and high school students.
- Ensure the athletic program aligns with the school's mission, values, and educational goals.

Leadership and Supervision:

- Hire, train, and supervise coaches and athletic staff.
- Foster a positive and inclusive culture within the athletic department.
- Conduct regular meetings with coaches to discuss program goals, policies, and procedures.

Compliance and Safety:

- Ensure all athletic programs comply with school policies, state regulations, and league requirements.

- Plan, develop, and deliver instructional PE and Health lessons aligned with district, state, and national standards.

- Integrate topics such as nutrition, mental health, substance abuse prevention, sexual education (as appropriate by grade), and overall wellness.

- Assess and monitor student progress using formative and summative assessment tools.
- Provide guidance and counseling to students regarding health related issues and concerns.

- Participate in professional development, school events, and extracurricular activities as needed.
